San Diego Anglers Goes to Web-Based Weight Receipt

Club members, you now have three ways to submit your weight receipt.

- 1. You can continue to download the latest SDA Official Weight Receipt from the club's website. Just look under the Form tab and click on the form named *SDA Weight Receipt (fill-in version) (PDF)*. You can then print the form out and complete manually and mail to the Weighmaster.
- 2. You can download the form to your computer, and fill in the information right on the PDF form. Then print out, sign, and mail to the Weighmaster. If you and your witness have an Adobe Electronic ID, you and your witness can electronically sign the Weight Receipt and email it to the Weighmaster.
- 3. Our newest way to submit your weight receipt is using our, web-based form that can be located at https://goo.gl/forms/mKrKNQ8awGlgf6H12. Just follow the instructions and complete all the questions. You will need to include your witness's name and phone number in order to complete submission of the form.




PROCEDURE TO APPLY FOR AWARDS:

- 2. Divers and shore-based anglers are exempt from season and depth restrictions affecting the RCG complex and other federally managed groundfish. However, when spear fishing during a boat-based closure, only spear fishing gear is allowed aboard any vessel or watercraft. Also, when angling from shore during a boat-based closure, no vessel or watercraft may be used to assist in taking or possessing species included in this table. The following definitions describe boat-based and shore-based anglers, and divers:
 - Boat-based anglers are fishermen that fish from boats or vessels of any size or any other type of floating object, including kayaks and float tubes.
 - Shore-based anglers are fishermen that fish from beaches, banks, piers, jetties, breakwaters, docks and other manmade structures connected to the shore.
 - Divers are spear fishermen entering the water either from the shore or from a boat or other floating object.
- See Section 27.50 for further information on fishing regulations in the Cowcod Conservation Areas.
- During the closed season, Pacific sanddab, butter sole, curlfin sole, flathead sole, rex sole, rock sole, and sand sole (defined as "Other Flatfish" in subsection 1.91(a)(10)) may be taken.
- See regulations for information on gear restrictions (Sections 28.65, 28.70, 28.90, 28.91, and 28.95) and fillet lengths (Section 27.65).
- Total length is the longest straight-line measurement from the tip of the head with the mouth closed to the end of the longest lobe of the tail. A measurement method illustration is available in the current Ocean Sport Fishing Regulations booklet.
- The sport fishery for leopard shark inside Newport Bay, Alamitos Bay, Mission Bay, and San Diego Bay is exempt from season and depth restrictions that affect other federally managed groundfish (Section 28.56).

EXCEPTION: During the open season, groundfish may be possessed in closed areas and in water depths closed to fishing only aboard vessels in transit with no fishing gear in the water (Section 27.20(b)).

- 1. The official starting time of the tournament is 06:00 am on Saturday, February 24th, 2018. The official ending time of the tournament is 3:00 pm on Saturday, February 24th, 2018.
- 2. Boats may depart prior to the official starting time of the tournament. Boats must depart from and return to any port within the county of San Diego. No tournament fishing is allowed prior to the official tournament starting time. All club tournaments are operated on an honor system.
- 3. The fishing areas of the tournament shall be in MISSION BAY (Drawing an Imaginary line between the entrance/exit jetties). No fishing within 100ft of Bait Barge.
- 4. During the tournament, fishing can be done from any fishing platform, including Sportfishing boats.
- 5. Bait may be caught, purchased or acquired as available prior to the official tournament starting time. Bait may be kept aboard tournament boats, used or transferred at the discretion of the anglers or skippers throughout the tournament.
- 6. IGFA angling rules will be used for this tournament. Angling rules can be found in the San Diego Anglers Yearbook under General Angling Rules. Anglers are responsible for compliance with all California or Mexican fishing and boating laws and regulations, as applicable.
- 7. All fish must be weighed on the club scale between 2:00 PM and 3:00 PM at the San Diego Anglers Tournament Weigh Station located at the SOUTH SHORES LAUNCH RAMP in Mission Bay.
- 8. Eligible Species: Calico Bass, Sand Bass, & Spotted Bay Bass. Entrants can weigh up to three (3) total fish from any combination of the eligible species (3-fish sack).
- 9. Prizes will be awarded in the following Categories: <u>Heaviest Sack Weight</u> 1st, 2nd, 3rd, 4th and 5th place for adults; 1st, 2nd and 3rd for juniors. There will be no ties in any category. When two sacks of the same weight are submitted, the first sack submitted is considered the winner.
- 10. Jackpot: There will be a \$10.00 optional Jackpot for the heaviest single bass.
- 11. All anglers are responsible to stay aware of current weather/sea conditions. Monitor NOAA weather radio for info.
- 12. All tournament anglers must complete, sign and submit a <u>Tournament Entry Form</u> and a <u>COPY OF THEIR CURRENT BOAT INSURANCE POLICY</u> prior to wetting a line in this fishing tournament. Entrants may sign up any time prior to the tournament starting date and time. The entry forms must be turned in to the locations or persons listed on the back of this form. All entrants in the tournament must be current members in good standing or non-members fishing as a guest of a club member. Entry forms can be scanned and emailed to Tournament Director (Adam Larson) with all pertinent signatures, boat insurance info (if applicable), and date/time stamp. By signing the application, Applicant does assume all risks of injury or property damage, and does agree to hold the San Diego Anglers harmless should any injury, death or property damage occur.

- 14. Tournament Angler of the Year and Skipper points will be awarded for this tournament.
